

- The initial training certification registration fee does not include TN Dep't of Ag's \$25 exam fee. Contact TDA at 615-837-5148 to pay exam fees.
- Training is normally offered the first Wednesday of each month by Interactive Television, ITV, in Knoxville and at other locations listed in Part III, pending sufficient number of preregistrations. For the second session in each month, locations other than Knoxville are generally not available.
- Preregistration with payment should be made to the Pesticide Safety Education Program (PSEP) office by eMarketplace (<http://tiny.utk.edu/conf-train>), mail (address below), or phone (865-974-1286) approximately two weeks prior to training.
- Check-in on training day for C7 with Core is at 7:45 a.m. ET (6:45 a.m. CT, see facilitator upon arrival) and Core, C3, C6 and LHA at 9:30 a.m. ET (8:30 a.m. CT).
- A certified applicator may earn 4 points in any category (Core) plus 2 points in C3, C7, C10, C12 & LHA and 1 point in C6 once per year at the monthly UT Commercial Applicator Initial Certification Meeting and four points in all categories at the UT Annual Recertification Meeting.
- Check-in for the recertification program is at 8:30 a.m. ET (7:30 a.m. CT). The program runs from 9 a.m. to 1 p.m. (8 a.m. to 12:00 noon CT).
